She holds an LL.B. from the University of Athens, an LL.M. from the London School of Economics, a Ph.D. in Law from the University of Athens, and a Graduate Diploma in English Law from BPP Law School. She conducted research at the University of Oxford, Columbia University, Cornell University and the University of Vienna.

She has been admitted to the Law Society in Greece since 2010 and to the Law Society of England & Wales since 2023. Her professional experience includes placements at international organisations in the Netherlands, Italy, Greece and the US, at EU institutions in Belgium, and at law firms in the UK, France and Greece. She is a member of the Chartered Institute of Arbitrators, YSIAC Council Member, Young ICCA Regional Representative, and Young ITA mentorship scheme facilitator. She also serves on the Peer Review Board of the American Review of International Arbitration.
