^oPlease note that Indian nationals planning to visit the Hong Kong Special Administrative Region (HKSAR) for a stay not exceeding 14 days are required to apply online for Pre-Arrival Registration (PAR) at:

https://www.immd.gov.hk/eng/services/visas/pre-arrival_registration_for_indian_nationals.html

A successful PAR is valid for a period of six months and multiple visits.

Participants who hold Indian passports have been advised by the Consulate General of India, Hong Kong, to apply for their PAR well in time. Indian passport holders may also wish to refer to the PAR advisory issued by the Consulate General of India in Hong Kong at https://cgihk.gov.in/news_detail/?newsid=498

In case a PAR is unsuccessful, Indian passport holders have the option to apply for a Hong Kong entry visa to Hong Kong Immigration Department at https://www.immd.gov.hk/eng/services/visas/visit_transit.html#firstTab which takes generally about 6 weeks of processing time.
